- Stripping and removal of E230 is almost completed and will be sold by the County. In process of reaching out to County to see what the next steps are.
- Currently there is a leak in the office from all the rain and he is getting prices for repair.
- Bureau of Indian Health has purchased the property recently that is the projected site for the rehabilitation facility. The facility will be 35000 sq. ft. and will house 36 patients.
